Inspection Trends

Almost every sale (please see below for reasons) had inspection reports completed at a minimum every fourteen (14 days).

On one sale (#210059), no inspection reports could be found and another sale couldn't be found on PP&I (#211045).

Progress with Objectives and Targets

Project status: all projects must be kept current. Found Sales were found where the PPI status did not reflect current status. Foresters must review all projects and update to current status by COB 06/15/2012.

Monitoring Results See above.

- 3. Concerns of Relevant Interested Parties

Local mills often inquire and are mostly content with the level of harvest in the county. Logging contractors have inquired as to the availability of Section 1 Permits. Beltrami County has not issued one in years and only in a rare and specific instance would a Section 1 Permit be granted and only if it benefitted the County.

Some contractors would like to see more than three auctions per year.

Responsible Operator/Contractor review and concerns:

Affield – didn't have pre-work prior to beginning sale – Field CAR issued

Loch – county-imposed probation expires late in 2012

D&J Hinrichs, Inc. – paying on a monthly basis Letter of Credit. Has already missed one monthly deadline.

Complaints – none.

Input from the General Public

Generally, routine inquiries as to what is planned on County land when local landowners see paint near their property. Communication with citizens has mostly answered questions to their satisfaction. PTAC will review timber sales that are scheduled for Three Island Park and Movil Maze. Discussed when it is appropriate to use **Form PR2-01 Version 2 – Public Complaint orInquiry.** Should and will use it in the case of the request of information on a sale in (or not in) the Movil Maze Recreational Area.

4. Review of research and scientific, technological or operational developments in practice of forestry: e.g.; Ash Diversification – Marshal Graham lead; MTIC Seed Orchards; LCCMR 7-County proposal: "Realizing County Forests Full Potential through Improved Inventory" – ~\$150,000/county; grouse drumming surveys; scent post surveys.

 - Monthly staff meetings will include discussing and overview of one procedure per month and one FSC® Principle per month. July 2012 staff meeting will start this process by discussing the need for LD-OP11 Boundary Line Marking V3 and the associated Beltrami County form.
